



**Instruction Sheet  
Fixed Mount**

**Read instructions completely before beginning installation.**

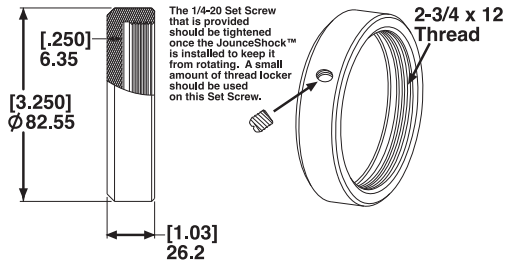
**Required Tools:**

- Welding equipment
- 1/8" hex key

**Using the Fixed Mount:**

The Fixed Mount is our most basic form of JounceShock mount. This threaded receiver comes in uncoated carbon steel so that it can be welded into any custom application as required. It provides a simple attachment point for the JounceShock. The Fixed Mount will most often be used with the Domed Foot (#25602) and Target Plate (#25608) or similar. You can refer to some of the solid axle systems that we offer for examples which utilize the Fixed Mount.

The Fixed Mount can also be used as the base receiver that can be welded into any conceivable mount or mounting system that the custom fabricator can create. It is up to the installer/fabricator to ensure that the structure that the mount is welded to is strong enough to carry the loads of the JounceShock. After welding, make sure to clean and paint the mount in order to limit future potential corrosion. Note that paint on the threads may make cause difficulty when installing. Use the 1/4"-20 Set Screw (provided) to keep the JounceShock from rotating. A small amount of thread locker should be use with this screw.
